- We do **not** store full credit card numbers on our servers
 - Payment data is encrypted and handled directly by QuickBooks
 - Payment processing is subject to QuickBooks' own privacy and security policies

Our website uses cookies and similar technologies to improve functionality and analyze traffic.

We use tools such as **Google Analytics** to collect aggregated, non-identifiable information including:

- Pages visited
- Time spent on the site
- General geographic region (city-level)

You may disable cookies through your browser settings. Disabling cookies may affect some website functionality.

6. Third-Party Disclosure

We may share personal information with trusted third parties only as necessary to operate our business, including:

- Website hosting providers
- Payment processors (QuickBooks)
- Analytics providers (Google Analytics)

- Email or form service providers

All such parties are required to maintain confidentiality and protect your information.

We may also disclose information where required to comply with legal obligations or to protect our legal rights.
